Newsletter: At the annual meeting, it was suggested that a quarterly newsletter would save the association money and still keep the membership informed. <u>Memorial weekend:</u> Facilities chair Jan Moon and I were called to the park multiple times regarding disrespectful members (co-owners, family and guests included). Two major issues were: checking in with the caretaker (with name and lot number) as they entered the park (stated in our park rules) and not knowing about the launch fee (information was in several past newsletters). He experienced confrontational and hostile interactions that also included unacceptable language. Many people told him they had never had to check in with the caretaker in the past. This requirement has been in place for years and if you have <u>never</u> had to do this in the past, then our previous caretakers were not enforcing the PSA park rules. It's no wonder he got a little grumpy after just 1 day! We do have board members that will meet with the unruly members and, if necessary, suspend park privileges.

2017 Annual meeting results: Three board members were elected to a 3 year term: Darlene Dennewith, Blair Harter and Joe Quarto (newest board member). Immediately following the 2017 Annual Meeting, the Board of Directors (BOD) met and elected new officers (this is done annually). Our 2017 PSA officers are: President Velinda Brown, Vice-President Tom Moore, Secretary Maureen Allen and Treasurer Brenda Bamford. An audit of the PSA financials records also did not pass. Financial information was also provided at the meeting and will be posted to the website shortly.

Safety/Security:

- We have been experiencing a high volume of break-ins here at Paradise Shores. At the Annual meeting several members admitted they did not report the incidents to the Sheriff's office. The Sheriff's office is encouraging us to call in and report so they can beef up patrols. There has been 1 arrest so far and some stolen items recovered. If you see any activity that seems suspicious, please call the <u>Sheriff's office at</u> 350-275-4467 Ext 313.
- Complaints received that boats are coming out of the marina too fast at the entrance/exit. The marina use is a privilege and not a right so the privilege can be revoked. State law mandates that you drive your boat 5mph to the last orange marker.
- Since there has been broken glass found on the swim beach, we are initiating a volunteer <u>"no glass on the beach"</u> rule beginning immediately.
- The floating dock outside the swim area is for <u>boats only</u>. There is no sun bathing or swimming off of this dock. Please observe the "No Wake Zone" as you leave/enter the marina. There are large amounts of cigarette butts being left all over the ground at the park. Please pick up after yourselves!

Please try and keep your property free of garbage and junk. We have been noticing a high volume of rats in our neighborhoods. Also, the members who walk regularly (some with leashed dogs) have asked if property owners/tenants could mow along the sides the roads. It would look great and they can avoid walking on the street.
