- Introductions:

  - Update on current reserve fund and marina income year to date. \$19,633.96
  - Understanding the marina replacement process presentation. by Blair Harter
    Building Permit Civil drawings PSA has these documents, elevations do not change.
  - Update on engineered drawings and permit submittal.
    - Structural Drawings CG Engineering is putting this together pile design, dock connections, lateral/horizontal loading, float design, hand calculations.

Blair reviewed the process that must be followed during permitting – the appropriate WAC's were listed. There is 5 year permit window.

Budget/Pricing – should be available next week from Orion.

Dean would like to have material available to present to members who are asking for a status report on the marina project.

Discussion ensued about contractors and sub-contractor usage.

The marina was failing a long time ago, we need to do this project right. We are looking at a 100 year Life design.

Velinda asked what we can do to prolong the life of the docks during the permitting process.

- Overall Marina Safety upgrades.
  - Cleaning and skimming marina. floating sediment must be controlled & cleaned up, if it leaves our marina it is considered pollution. 1<sup>st</sup> time is a fine, 2<sup>nd</sup> time is a shutdown.
    Rob Koenig suggested a marina skimmer, ballpark cost is approximately \$10-15000.
  - Clearing Juniper vegetation from boat launch area. Needs to be cut back to the wall at

the very least.

- Project spreadsheet
  - Review budget pricing from Orion Marine Group and discuss financing / moorage fees and payback.
     Add the skimmer to the budget. Aqua Technix needs to be scheduled.
  - Removal of yellow flag iris Invasive species.
