Additional Health Information

Contaminants in Drinking Water:

Drinking water including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the number of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health. Sources of drinking water (both tap water and bottled water) can include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animal or human activity.

Lead in Drinking Water:

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. **Paradise Estates** is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Cross Connection:

You might have seen cross-connection surveys sent to you by mail. Here is a little information on why:

Cross-connections are found in all plumbing systems. It is important that each cross-connection be identified and evaluated as to the type of back-flow protection required to protect the drinking water supply. Some plumbing fixtures have built-in back-flow protection in the form of a physical air gap. However, most cross connections will need to be controlled through the installation of an approved mechanical back-flow prevention device or assembly.

- Turn water off while brushing your teeth and rinsing your dishes!
- Cut the time per shower by a few minutes and save up to 150 gallons per month!
- Run full loads in dishwasher and washing machine.
- Insulate hot water pipes to save water and energy!

What Are PFAS?

In Washington State, PFAS were used in certain types of firefighting foams.
