Park Rules

- The park is open April 1st to October 31st from 8am-dusk.
- Members and guests **must check in per visit** with the caretakers upon entering the park, you will be asked for member's name and lot number.
- **Masks are required when entering the park until further notice**
- Vehicles are to park in designated areas only or as directed, 15-minute limit in load/unload zone, keep speed under 5 mph.
- Children under 12 must be supervised (adult preferred) while in the park.
- Load/Unload dock (off main jetty) is for boaters only (no swimming/sunbathing allowed).
- No lifeguard is on duty, swim at your own risk.
- No bicycles or pets are allowed past the sports court. Pets are to be on leashes at all times/clean up after them.
- No bicycles, rollerblades, skateboards, or scooters on the sports court.
- Fires are allowed in fire pit (provided) only.
- Dumpsters are for park use only. Please use garbage's located throughout the park.
- **Smoking and vapes are allowed in designated area only, east side of park** (a picnic table and ash tray are provided).
- No fireworks are allowed in the park at any time.
- No swimming or fishing in the marina.
